Date - 15-09-2023

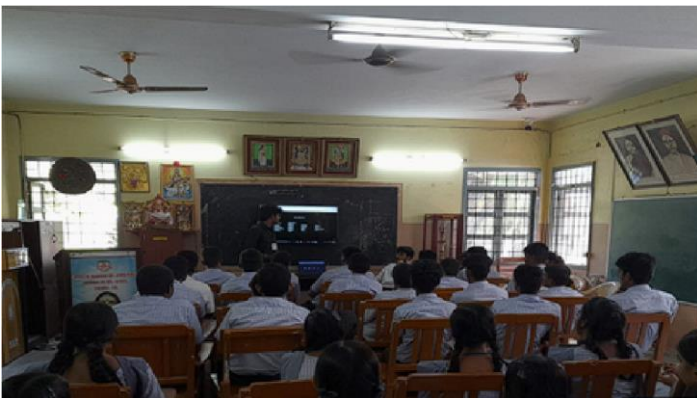

BASIC NEEDS DONATION DRIVE

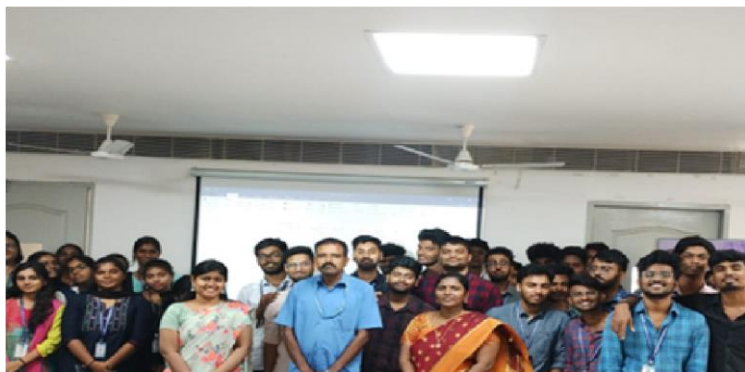
Date – 03-01-2024
