## OUR COLLEGE OUR PRIDE

DG Vaishnav College (Dwaraka Doss Goverdhan Doss Vaishnav College), commonly known as DDGDVC, is a Liberal arts, commerce and science college in Chennai, India. It is an autonomous institution affiliated with the University of Madras. It is located in the Arumbakkam locality of Chennai, which is a hub for many shops and markets, of which the most famous Koyembedu market and bus stand. It was recently reaccredited by NAAC with an A++ grade ( CGPA of 3.54 /4) in the 3rd cycle.



DG Vaishnav College was affiliated with the University of Madras, however, the College has been conferred the status of "AUTONOMY" by the UGC and endorsed by the University of Madras from the academic year 2009 - 2010. Consequently, students admitted to various UG, PG and M.Phil. courses during the academic year 2009 - 2010 will come under an Autonomous pattern. The extension of autonomy was given by the UGC up to 2032-2033.



## **DEPARTMENT OF B.COM FINANCE & TAXATION**

The Department of B.com (Finance and Taxation) provides a course on International Taxation and Technology in addition to regular Indian taxation. The course is a unique one, earning MOUS with EY and ACCA and Exemption of F6, Taxation (TX) in ACCA.

The most important aspect of the course is its curriculum, highlighting its outcome of enabling the learner to obtain a level where they can qualify as Tax consultants, fulfilling the expectations of Big 4's like EY.

Additionally, the curriculum is designed in such a way that, the learner understands the differences and the parallels of both Indian and International taxation, creating a pragmatic approach to understanding Progressive Taxation building from the basics of understanding the federal tax, legislative process, Jurisdiction, and Tax system to giving them a glimpse on the new digital tax function and the role of technology as it underpins the working and answers the mandate of the global digital Economy.

## INTREGRATION WITH ACCA

B.Com (Finance & Taxation) is integrated and embedded with ACCA Syllabus with paper exemptions. ACCA (The Association of Chartered Certified Accountants of the United Kingdom) is the global body for professional accountants, who support their members and students throughout their careers, providing services through a network of 104 activity centres.



## Think Ahead

The course curriculum of B.Com Finance & Taxation is integrated with ACCA, with an exemption of six out of thirteen ACCA papers. Moreover, another three papers are integrated into the syllabus, which is treated as non-exempted papers. ISDC (International Skill Development Corporation), which is our official partner for ACCA integration, conducts ACCA classes on the campus exclusively for the three non-exempted subjects.
