S.No.	NAME OF THE SCHOLARSHIP	PARTICULARS – ELIGIBILITY CRITERION
1	Shakuntala Devi Charitable Trust	The scholarship is given to promote education for students in the low-income group. The scholarship would be given to meritorious students who do not have arrear records previously.
2	Swethambu Terapanthi	The scholarship is based on identifying the needy students who would require financial help for enrolling themselves in to higher education. The scholarship focuses on the educational requirements of the low-income group of students who have maintained above 60% aggregate marks in their examinations.
3	Sohan Kanwar Mangilal Tatr	The philanthropical initiatives taken by the individual to enable the meritorious students to gain quality higher education and skill enhancement. This scholarship is based on the community criterion and also is applicable to those who have not availed any other form of scholarship/funding.
4	Jain Sindhia Trust	The scholarship is given to the students who have secured above 60% marks in HSS Examination. The scholarship will be discontinued if the student is not able to maintain 60% and above marks in the forthcoming examinations.
5	Rajasthani Association	The scholarship is based on community. These students who have been benefitted by this scholarship should not have availed any scholarship on the SC/ST basis. The Rajasthani Association also helps the students financially to have proper hostel facilities. The basis of the scholarship is based on merit. The students should not have availed Government Scholarship.
6	Opportunity Foundation	The scholarship is focussed on enabling the students to have equitable opportunities from all strata of life and income group. The students who belong to the lower income group can avail this scholarship based on their meritorious performance.
7	Anjaneyar Trust	The scholarship is based on the Income. Students belonging to low-income group can avail this scholarship.





